- _____ Eye and Ear protection must be worn at all times. Long Sleeve shirt and Long Pants.
- _____ If you must leave the range, a safety officer will help you to properly secure your firearm.
- _____ Absolutely no pregnant women are allowed on the range.
- _____ Leave your pride in the parking lot.
- _____ A positive attitude should be exhibited at all times.

Range Rules

- The Range Office has full authority on the range at Lou Land Gun Club and Instructions will be followed at all times. Instructions from Range officers are Final!
- Anyone with alcohol on their breath, or appears to be, impaired in anyway the Range Officer will removed them from within the range area.
- Eye and ear protection is required at all times on the range.
- Members are responsible for their guest range behavior and etiquette at all times.
- No holster draw from firing line
- Line Hot: Line is hot, safe to shoot
- Line Cold: Line is cold you will completely unload & bench firearm, step away from the shooting point.
- Absolutely No gun handing when the line is cold. No loading magazines and or adjusting sights or scopes.
- All firearms must be made safe **actions open** prior to anyone going down range.
- All unloading and loading is done from the shooters firing point, with the firearm pointed down range.
- **Firearms must be pointing in a safe direction at all times no exceptions.**
- No handling firearms behind the firing line.
- **Only paper targets are permitted.** Absolutely no shooting of cans, bottles or other items.
- **Absolutely** No use of tracer ammo.
- No horseplay or goofing around on the range.
- In the event of a malfunction that the shooter is unable to clear, bench the firearm down range and notify a Range Officer to assist you.
- Report any unsafe behavior immediately to a range Officer.
- Police all brass and trash when done shooting.
- All firearms must be unloaded and cased prior to leaving the range.
- Children must be in direct supervision by parent at all times.
- **ANYONE CAN CALL A CEASEFIRE**

I have read and understand all of the range rules and agree to be bound by them at all times while participating in activities at Lou Land Gun Club. I understand that any breach of the above rules will result in immediate removal from the range by the Range Officer or the Owner. I further understand that I will not be eligible for a refund of any monies paid in the event if I am removed due to my failure to the any of the rules herein described.
